1. **Call to order and record attendance:** Carolyn Lynch, president, called the meeting to order at 5:30 p.m.

2. Approval of agenda

Fortunately, PSPL has been able to fill voids quickly with quality personnel. General discussion about the level of noise, in general, in the library. Some interest in designing a "quiet zone" behind the stairs on the first floor, as the current Quiet Reading Room may no longer be feasible. A suggestion to reconfigure the teen area as a solution, was raised.
